N. on Rt. 31 (left)

E. on Rt. 56 (right)

(Cross the Fox River, follow the road to the left, cross railroad track and turn left at the light - Rt. 25.)

N. on Rt. 25

Going north on Rt. 25 from Rt. 56, you will pass the Red Oak Nature Center on your left and a golf course on your right. When you see the Shagbark Rd. sign on your right, immediately look to your left and turn left at the green Lippold Park sign. You will see a stop sign and a railroad crossing. As you cross the railroad track, the indoor range is in the building in front of you. Follow the road to the right and park in the parking lot north of the building. Walk back to the building and go down the driveway to the rear of the building and enter through the first set of doors.
