N. on Rt. 31 (turn left)

E. on Rt. 56 (turn right right)

(Cross the Fox River, follow the road to the left, cross railroad track and turn left at the light - Rt. 25.)

N. on Rt. 25

Going north on Rt. 25 from Rt. 56, you will pass the Red Oak Nature Center on your left and the Fox Valley Country Club on your right. When you see the Shagbark Rd. sign on your right, immediately look to your left and turn left at the Lippold Park sign and mailbox just before you reach Shagbark Rd. You will see a stop sign and a railroad crossing. As you cross the railroad track, the indoor range is in the building in front of you. Follow the road to the right and park in the parking lot north of the building. Walk back to the building and enter through the first set of doors on the lower level.
